



SUMMARY OF LIVING DONOR PROTECTIONS





Introduction

Many people do not know that medical expenses associated with living donor evaluation and donation are fully covered by the recipient's health insurance. Despite this, there may be other costs associated with donating a kidney that you should prepare for. The good news is that there are many organizations and resources available to you to offset these costs. Having knowledge of, and using these resources, can ensure that you do not pay any money out of pocket when you donate a kidney.

Below is a list of expenses that are not covered by the recipient's insurance:

- Lost wage reimbursement
- Dependent care reimbursement
- Transportation, lodging, and meals for the donor and a support person on evaluation, donation surgery, and follow-up trips to the transplant center for up to 2 years after the donation surgery.

RESOURCES THAT CAN OFFSET THE COSTS OF LIVING DONATION



Support from the Kidney Recipient

While it is illegal to pay somebody to donate a kidney, it is legal to reimburse a donor for expenses related to donation that are not covered by the recipient's insurance. If your intended recipient knows that you are stepping forward to donate, it is acceptable to seek their assistance to help cover expenses related to your testing and donation.

National Living Donor Assistance Center (NLDAC) | www.livingdonorassistance.org

The National Living Donor Assistance Center (NLDAC) is a federally funded program that helps eligible living organ donors with their travel, lost wages, and dependent care expenses.

Individuals considering becoming a living organ donor can apply for help with their travel expenses, lost wages, and dependent care expenses from NLDAC if they cannot be reimbursed for these costs by their recipient, a state program, or an insurance company. The transplant recipient will be required to submit information about their financial status for NLDAC to determine if the donor is eligible. Eligibility is determined by the transplant recipient's household income.

Assistance from the National Kidney Registry (NKR) & Alliance for Paired Kidney Donation (APKD)

In the event you are not a match for your intended recipient, or you do not have an intended recipient, you will have the opportunity to be part of a paired exchange. When you participate in an exchange program, you will have several additional benefits and protections available to you.

BENEFITS INCLUDE:

- Lost wage reimbursement for up to 4 weeks
- Travel, lodging, food & mileage reimbursement for donors and their support person
- Life insurance for \$1,000,000 for a kidney donation-related death
- In many cases, a wide range of insurance options that will support your donation
